CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WASTE WATER from NW¼ of NW SE, Sec 34, tributary to the Little Walla River for SUPPLEMENTAL IRRIGATION on 46.91 ACRES.

This right was perfected under Permit S-44746. The priority date is 8/2/1979. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.244 cubic foot per second (cfs) or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre; provided that the right allowed herein shall be limited to any deficiency in the available supply of any prior rights existing for the same land and shall not exceed the limitation allowed herein, provided further that the amount of water rediverted from the channel of the Pleasant View Irrigation Company Ditch shall not exceed the amount by which the flow of said ditch at the point of rediversion is increased above the flow by the introduction of waste water from the source identified, and measuring devices be installed and maintained as directed by the Watermaster, and shall also be limited to the water available at the proposed point of diversion and shall not carry with it the right to compel the continuance of waste water. The use shall conform to such reasonable rotation system as may be ordered by the proper state official.

A description of the place of use to which this right is appurtenant is as follows:
