CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of the Little Walla Walla River, tributary to the Walla Walla River for IRRIGATION on 19.55 ACRES and FROST PROTECTION on 28.35 ACRES.

This right was perfected under Permits E-241, S-4342, and S-39314. The priority dates are 6/24/1915 and 12/15/1919 for Irrigation, and 7/25/1974 for Frost Protection. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 1.223 cubic feet per second (cfs), being 0.249 cfs for IRRIGATION and 0.974 cfs for FROST PROTECTION, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:
