 CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of the Little Walla Walla River, tributary to the Walla Walla River for IRRIGATION on 19.07 ACRES and SUPPLEMENTAL IRRIGATION on 24.20 ACRES.

This right was perfected under Permits S-2765 and S-26001. The priority dates are 12/24/1915 for IRRIGATION and 1/16/1959 for SUPPLEMENTAL IRRIGATION. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.0847 cubic foot per second (cfs), being 0.240 cfs for IRRIGATION and 0.607 cfs for SUPPLEMENTAL IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for SUPPLEMENTAL IRRIGATION, together with the amount secured under any other right existing for the same lands, is limited to 0.0375 (3/80) of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state official.

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes the water right confirmed by Certificates 1234 and 86964 (90700), State Record of Water Right Certificates, modified by the provisions of an order of the Water Resources Director entered MAY - 5 2017, approving a petition by Walla Walla River Irrigation District under ORS 541.329 for mapping water rights within a district. This certificate supersedes Certificates 1234 and 86964 (90700).
