CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of a WELL, tributary to the Walla Walla River for SUPPLEMENTAL IRRIGATION on 37.4 ACRES.

This right was perfected under Permits G-4100 and G-11030. The priority dates are 4/23/1968 for 0.15 cfs, and 2/14/1990 for 0.23 cfs. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.38 cubic foot per second (cfs), or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of appropriation is located as follows:

Well #2 shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works shall be equipped with a useable access port, and may also include an air line and pressure gauge to determine the water level elevation in the well at all times. When required by the Department, the water user shall install and maintain a weir, meter, or other suitable measuring device and keep a complete record of the amount of ground water withdrawn. The Director may require water level or pump tests every ten years.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion not to exceed 3.0 acre-feet for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not be limited to any deficiency in available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The use shall conform to such reasonable rotation system as may be ordered by the proper state official.

A description of the place of use to which this right is appurtenant is as follows:
