CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO:

Kenneth H. and Tracy A. Arnzen 53332 Hwy 332 OR 97862,

confirms the right to use the waters of the Little Walla Walla River, tributary to the Walla River for IRRIGATION on 8.6 ACRES and SUPPLEMENTAL IRRIGATION on 8.6 ACRES.

This right was perfected under Permits E-170 and S-26001. The priority dates are 5/3/1913 for IRRIGATION and 1/16/1959 for SUPPLEMENTAL IRRIGATION. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.324 cubic foot per second (cfs), being 0.108 cfs for IRRIGATION and 0.216 cfs for SUPPLEMENTAL IRRIGATION, or their equivalents in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH (1/80) of one cfs per acre for IRRIGATION, and is limited to 0.0375 cfs (3/80) per acre for SUPPLEMENTAL IRRIGATION, or its equivalent for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state official.
