## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO:

confirms the right to use the waters of WASTE WATER, tributary to the Walla Walla River for SUPPLEMENTAL IRRIGATION on 8.5 ACRES.

This right was perfected under Permit S-28001. The priority date is 4/26/1962. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.215 cubic foot per second (cfs) or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion not to exceed 3.0 acre-feet per acre irrigated during the irrigation season of each year; and shall also be limited to the water available at the proposed point of diversion and shall not carry with it the right to compel the continuance of the water. The use shall conform to such reasonable rotation system as may be ordered by the proper state official.

A description of the place of use to which this right is appurtenant is as follows:
