CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of a WELL, tributary to the Walla River for SUPPLEMENTAL IRRIGATION on 42.0 ACRES.

This right was perfected under Permit G-4880. The priority date is 3/31/1970. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.454 cubic foot per second (cfs) or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of appropriation is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion not to exceed 3.0 acre-feet per acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others. The use shall conform to such reasonable rotation system as may be ordered by the proper state official.
