CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO:

confirms the right to use the waters of TWO WELLS in the SOUTH BRAN MUD CREEK BASIN, for SUPPLEMENTAL IRRIGATION on 20.0 ACRES and FROST PROTECTION on 20.0 ACRES.

This right was perfected under Permit G-10441. The priority dates are 03/14/1984 for 0.952 cubic foot per second (cfs) and 04/16/1984 for 0.952 cfs. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 1.904 cubic feet per second (cfs), being 1.655 cfs for FROST PROTECTION and 0.249 cfs for SUPPLEMENTAL IRRIGATION, or their equivalents in case of rotation, measured at the point of diversion from the source.

The points of appropriation are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cfs per acre for SUPPLEMENTAL IRRIGATION, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein. The use shall conform to such reasonable rotation system as may be ordered by the proper state official.

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
