CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO:

Roloff Farms Inc. 151 Bradley St. Walla Walla, WA 99362

confirms the right to use the waters of WASTE WATER from the West 14.15 acres of NWNW, and the NWSW, Sec. 36, T 6N, R 35E, W.M., for IRRIGATION on 6.63 ACRES and SUPPLEMENTAL IRRIGATION on 9.45 ACRES.

This right was perfected under Permits S-14450 and S-29921. The priority dates are 5/23/1940 for IRRIGATION and 8/4/1964 for SUPPLEMENTAL IRRIGATION. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.367 cubic foot per second (cfs), being 0.248 cfs for IRRIGATION and 0.119 cfs for SUPPLEMENTAL IRRIGATION, or their equivalents in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to 0.0375 cfs (3/80) of one cfs per acre for IRRIGATION, and ONE-FORTIETH (1/40) cfs per acre for SUPPLEMENTAL IRRIGATION. The SUPPLEMENTAL IRRIGATION shall be further limited to a diversion not to exceed 3.0 acre feet per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

This right does not carry with it the right to require the wasteful use of water by others. The use shall conform to such reasonable rotation system as may be ordered by the proper state official.

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
