CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of a WELL, in the Little Walla Walla Basin for SUPPLEMENTAL IRRIGATION on 78.73 ACRES.

This right was perfected under Permit G-11575. The dates of priority are JANUARY 8, 1990 for 0.629 cfs and JULY 16, 1992 for 0.060 cfs. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.689 cubic foot per second (cfs) or its equivalent in case of rotation, measured at the well.

The point of appropriation is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion not to exceed 4.5 acre-feet per acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state official.

A description of the place of use to which this right is appurtenant is as follows:

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate describes the water right confirmed by Certificate 85730, State Record of Water Right Certificates, modified by the provisions of an order of the Water Resources Director entered MAY - 5 2017, approving a petition by Walla Walla River Irrigation District under ORS 541.329 for mapping water rights within a district. This certificate supersedes Certificate 85730.
