CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO:

Walla Walla, WA 99362

confirms the right to use the waters of the Crockett Branch of the Little Walla Walla River, tributary of the Walla Walla River, for IRRIGATION on 1.0 ACRE.

This right was perfected by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 12 at Page 9. The priority date is 1908.

The use is limited to 1.5 MINER'S INCHES PER ACRE, or 0.037 cubic foot per second, or its equivalent in case of rotation, if available at the original points of diversion as follows:

The point of diversion is located as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described, and the right shall be subject to all other conditions and limitations contained in the above-described decree.

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes the water right confirmed by Certificates 49292 and 49293, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered MAY - 5 2017, approving a petition by Walla Walla River Irrigation District under ORS 541.329 for mapping water rights within a district. This certificate, together with Certificate 92543, supersedes Certificates 49292 and 49293.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
