CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO:

Burlingame Land and Livestock Inc. Box 60 Touchet, WA 99360

confirms the right to use the waters of TWO WELLS in the Umatilla Basin, tributary to the Walla River for IRRIGATION on 73.6 ACRES and SUPPLEMENTAL IRRIGATION on 56.1 ACRES.

This right was perfected under Permit G-3882. The priority date is 11/6/1967. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.626 cubic foot per second (cfs), being 0.218 cfs from Well No. 1 and 0.408 from Well No.2, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of appropriation are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion not to exceed 3.0 acre-feet per acre irrigated during the irrigation season of each year. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
