## CERTIFICATE OF WATER RIGHT

## THIS CERTIFICATE ISSUED TO:

Church Of Jesus Christ LDS c/o Real Estate Division 50 E North Temple Salt Lake City, UT 84150

confirms the right to use the waters of a WELL in the Umatilla River Basin, tributary to the Walla Walla River for IRRIGATION on 2.0 ACRES and TEMPERATURE CONTROL WITHIN A CHAPEL.

This right was perfected under Permit G-10526. The date of priority is June 26, 1985. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.21 cubic foot per second (cfs), being 0.05 cfs for IRRIGATION and 0.16 cfs for TEMPERATURE CONTROL or its equivalent in case of rotation, measured at the well.

The point of appropriation is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion not to exceed 4.5 acre-feet per acre irrigated during the irrigation season of each year; provided that the use of water for temperature control in the chapel in excess of 5000 gallons per day shall be subsequent in priority to future beneficial consumptive use unless the effluent is reinjected to a suitable ground water reservoir or put to a beneficial consumptive use. The use shall conform to such reasonable rotation system as may be ordered by the proper state official.
