## CERTIFICATE OF WATER RIGHT

## THIS CERTIFICATE ISSUED TO:

Donald L. and Debra J. Slusarenko 53522 Hwy. 332 Milton-Freewater, OR 97862

confirms the right to use the waters of the Ford Branch Little Walla River, tributary to the Walla Walla River for IRRIGATION on 0.2 ACRE and SUPPLEMENTAL IRRIGATION on 0.2 ACRE.

This right was perfected under Permits S-39034, S45372, and S-26001. The priority dates are 4/15/1974 for 0.006 cfs, and 11/20/1980 for 0.009 cfs for IRRIGATION, and 1/16/1959 for 0.005 cfs for SUPPLEMENTAL IRRIGATION. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.02 cubic foot per second (cfs), being 0.015 cfs for IRRIGATION and 0.005 cfs for SUPPLEMENTAL IRRIGATION, or their equivalents in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for SUPPLEMENTAL IRRIGATION, together with the amount secured under any other right existing for the same lands, is limited to 0.0375 cfs (3/80) per acre, or its equivalent for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state official.

This certificate, together with Certificate 92574, supersedes Certificates 48082, 64624, and 86964 (90700).

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
