 CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WELLS 8, 9, and 10, tributary of the Little Walla Walla River for SUPPLEMENTAL IRRIGATION on 1.09 ACRES.

This right was perfected under Permit G-7392. The priority dates is 3/15/1977. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.027 cubic foot per second (cfs), being 0.003 cfs from Well 8, 0.003 cfs from Well 9, and 0.021 cfs from Well 10, or its equivalent in case of rotation, measured at the point of diversion from the well.

The points of appropriation are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH (1/40) of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion not to exceed 4.5 acre-feet per acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state official.

A description of the place of use to which this right is appurtenant is as follows:

The right to the use of water for the above purposes is restricted to the lands or place of use described above.

This certificate describes the water right confirmed by Certificate 55618, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered MAY - 5 2017, approving a petition by Walla Walla River Irrigation District under ORS 541.329 for mapping water rights within a district. This certificate, together with Certificate 92596, supersedes Certificate 55618.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
