## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WASTE WATER from the NWSW of Sec. 36, T6N, R35E, W.M. for SUPPLEMENTAL IRRIGATION on 0.05 ACRE.

This right was perfected under Permit S-29921. The priority date is 8/4/1964. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.001 cubic foot per second (cfs) or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH (1/40) of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion not to exceed 3.0 acre-feet per acre irrigated during the irrigation season of each year; and shall not carry with it the right to compel the continuances of the waste water. The use shall conform to such reasonable rotation system as may be ordered by the proper state official.
