## CERTIFICATE OF WATER RIGHT

## THIS CERTIFICATE ISSUED TO:

Schichtel's Nursery Oregon, Inc. 6745 Chestnut Ridge Rd. Orchard Park, NY 14127

confirms the right to use the waters of a WELL in the UMATILLA BASIN for IRRIGATION on 1.3 ACRES and SUPPLEMENTAL IRRIGATION on 40.0 ACRES.

This right was perfected under Permit G-10765. The priority date is 4/10/1987. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.155 cubic foot per second (cfs) being 0.005 cfs for IRRIGATION and 0.150 cfs for SUPPLEMENTAL IRRIGATION, or their equivalents in case of rotation, measured at the well.

The point of appropriation is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH (1/80) of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall be further limited to the appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others. The use shall conform to such reasonable rotation system as may be ordered by the proper state official.

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes the water right confirmed by Certificate 83545, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered \_\_\_\_\_\_\_\_, approving a petition by Walla Walla River Irrigation District under ORS 541.329 for mapping water rights within a district. This certificate, together with Certificate 92669, supersedes Certificate 83545.

The well shall be maintained in accordance with the General standards for the Construction and Maintenance of Water Wells in Oregon.

The water user shall install and maintain a weir, meter, or other suitable measuring device and keep a complete record of the amount of ground water withdrawn.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
