## CERTIFICATE OF WATER RIGHT

## THIS CERTIFICATE ISSUED TO:

Schichtel's Nursery Oregon, Inc. 6745 Chestnut Ridge Rd. Orchard Park, NY 14127

confirms the right to use the waters of Little Walla Walla River, tributary of the Walla Walla River for IRRIGATION on 1.3 ACRES and SUPPLEMENTAL IRRIGATION on 0.9 ACRES.

This right was perfected under Permits E-177 and S-26001. The priority dates are 6/30/1913 for IRRIGATION and 1/16/1959 for SUPPLEMENTAL IRRIGATION. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.039 cubic foot per second (cfs), being 0.016 cfs for IRRIGATION and 0.023 cfs for SUPPLEMENTAL IRRIGATION, or their equivalents in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for SUPPLEMENTAL IRRIGATION, together with the amount secured under any other right existing for the same lands, is limited to 0.0375 cfs (3/80) per acre, or its equivalent for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state official.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described, and the right shall be subject to all other conditions and limitations contained in the above described decree.
