 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ELK CREEK FARM LLC
 1868 SCHAD RD
 ELKTON, OR 97436

confirms the right to use the waters of SPRINGS , a tributary of ELK CREEK AND ELK CREEK for DOMESTIC USE FOR ONE FAMILY INCLUDING NOT TO EXCEED ½ ACRE LAWN AND NON-COMMERCIAL GARDEN IRRIGATION AND IRRIGATION OF 13.2 ACRES .

This right was perfected under Permit S-44863 . The date of priority is December 13, 1979. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.18 CUBIC FOOT PER SECOND (CFS), BEING 0.01 CFS FROM SPRINGS FOR DOMESTIC USE AND 0.17 CFS FROM ELK CREEK FOR IRRIGATION , or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

If for irrigation, this appropriation shall be limited to ONE-EIGHTIETH of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

This right is subject to existing rights including the existing flow policies established by the Water Policy Review Board.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
