CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of A WELL, in the LOST RIVER (TULE LAKE) BASIN for IRRIGATION OF 66.9 ACRES.

This right was perfected under Permit G-1975. The date of priority is OCTOBER 25, 1961. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.83 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The point of appropriation is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued in accordance with OAR 690-380-6010 to describe the water right for a non-completed additional point of appropriation approved by an order of the Water Resources Director entered September 3, 2003, at Special Order Volume 58, Pages 111-118, approving Transfer Application T-8553 and supersedes Certificate 34767, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to beneficial use on the lands or place of use herein described.
