 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ERIK L. JOHNSEN  
 3606 THREEMILE RD  
 THE DALLES, OR 97058

confirms the right to use the waters of WELL 3 (WASC 50498) within the THREEMILE CREEK BASIN for IRRIGATION OF 52.8 ACRES.

This right was perfected under Permit G-482. The date of priority is APRIL 16, 1947. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.45 CUBIC FOOT PER SECOND (CFS), provided further that the amount of water allowed herein in combination with water use allowed by Certificate 92996, shall not exceed 0.45 CFS of water or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of ONE-EIGHTIETH of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The quantity of water diverted at the new point of appropriation WELL 3 (WASC 50498), shall not exceed the quantity of water available from the original point of appropriation described as follows:

Water shall be acquired from the same aquifer as the original point of appropriation.

This certificate describes that portion of the water right confirmed by Certificate 89642, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered APR 20 2017, approving Transfer Application T-12518.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
