The amount of water to which such right is entitled, for the purposes of aforesaid, is limited to an amount beneficially used for said purposes, and shall not exceed THE RATE OF ONE CUBIC FOOT OF WATER PER SECOND OF TIME FOR EACH 70 ACRES OF LAND IRRIGATED DURING THE IRRIGATION SEASON.

A description of the place of use, and to which the water is appurtenant, is as follows:

The water user shall maintain a headgate and inline flowmeter for measuring and recording the quantity of water diverted.

The quantity of water diverted at the new points of diversion shall not exceed the quantity of water lawfully available at the original point of diversion.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Water shall be acquired from the same surface water source as the original point of diversion.

The water user shall maintain a fish screen, as required by the Oregon Department of Fish and Wildlife.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

This certificate describes that portion of the water right confirmed by Certificate 9686, State Record of Water Right Certificates, reduced in rate and duty by the provisions of an order of the Water Resources Director entered MARCH 19, 2003, at Special Order Volume 57, Page 220, approving Allocation of Conserved Water Application CW-22. This certificate is also issued to confirm changes in POINTS OF DIVERSION and PLACE OF USE approved by an order of the Water Resources Director entered APRIL 24, 2003, at Special Order Volume 57, Page 484, approving Transfer Application T-9168, This certificate together with Certificates 80692 and 93054 supersedes Certificate 9686, State record of Water Right Certificates.
