CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to the use of water perfected under the terms of Permit S-3871. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point(s) of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: WOOD CREEK, A TRIBUTARY OF WINDY CREEK

PURPOSE OR USE: IRRIGATION OF 2.7 ACRES

MAXIMUM RATE: 0.026 CUBIC FOOT PER SECOND

DATE OF PRIORITY: APRIL 12, 1918

The points of diversion are located as follows:

32 S	6 W	WM	27	NW NE	POD 2 - 831 FEET SOUTH AND 230 FEET EAST FROM N1/4 CORNER, SECTION 27

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent in case of rotation.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the lands irrigated under the right hereby confirmed, and to which such right is appurtenant is as follows:

The water user shall maintain the meter in good working order and shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

The water user shall maintain a headgate and inline flowmeter for measuring and recording the quantity of water diverted.

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the new points of diversion shall not exceed the quantity of water lawfully available at the original point of diversion.

Water shall be acquired from the same surface water source as the original point of diversion.

The water user shall maintain a fish screen, as required by the Oregon Department of Fish and Wildlife.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

This certificate is issued to confirm the finalization of allocation of conserved water application CW-22 in an order of the Water Resources Director entered MARCH 19, 2003, at Special Order Volume 57, Page 220, Final Order Approving the Use of the Conserved Water. This certificate is also issued to confirm changes in POINTS OF DIVERSION and the portion of the PLACE OF USE confirmed in the finalization of allocation of conserved water application CW-22 which was approved by an order of the Water Resources Director entered APRIL 24, 2003, at Special Order Volume 57, Page 484, approving Transfer Application T-9168. This certificate together with Certificates 80058, 80693, and 93051 supersedes Certificate 5063, State record of Water Right Certificates.
