CERTIFICATE OF WATER RIGHT

confirms the right to the use of water perfected under the terms of Permit S-12666. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: BIRCH CREEK, A TRIBUTARY OF THE UMATILLA RIVER

PURPOSE OR USE: IRRIGATION OF 8.86 ACRES

MAXIMUM RATE: 0.15 CUBIC FOOT PER SECOND

DATE OF PRIORITY: MAY 27, 1937

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second or the equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the new points of diversion, shall not exceed the quantity of water lawfully available from the original points of diversion described as follows:

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.


The water user shall maintain a fish screen or fish by-pass device, as appropriate, at the point of diversion.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered December 29, 2004, at Special Order Volume 62, Page 419, approving Transfer Application 9776, and together with Certificate 81002, supercedes Certificate 80632, State record of Water Right Certificates.
