CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

A.W. GUTHRIE MURPHY, OR

confirms the right to the use of waters of SLAGLE CREEK, a tributary of APPLEGATE RIVER, for PRIMARY IRRIGATION of 8.4 ACRES and SUPPLEMENTAL IRRIGATION of 7.6 ACRES.

The date of priority is 1877. The amount of water to which this right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.16 CUBIC FOOT PER SECOND (CFS) for Tract No. 1, 0.10 CFS for Tract No. 2, and 0.05 CFS for Tracts 3 & 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one CFS per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484 and ORS 536.075. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 183.484, ORS 536.075 and OAR 137-004-0080, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.

Certificate 16423.bp

This certificate describes that portion of the water right modified by provisions of an order recorded at Special Order Volume 104, Page 791, diminishing a portion of the right evidenced by Certificate 16423. This certificate supersedes water right Certificate 16423.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
