CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

R T. RENNER
 ROUTE 7
 LAKEVIEW, OR 97630

confirms the right to use the waters of DREWS CREEK AND DREWS CREEK SLOUGH, tributaries of GOOSE LAKE for the purpose of IRRIGATING 185.8 ACRES FROM DREWS CREEK SLOUGH AND 319.1 ACRES FROM DREWS CREEK AND DREWS CREEK SLOUGH.

This right was perfected under Permit S-22471. The date of priority is SEPTEMBER 8, 1941 FOR 4.74 CFS AND MAY 20, 1953 FOR 3.62 CFS. This right is limited to 9.65 CUBIC FEET PER SECOND BEING 4.48 FROM DREWS CREEK AND 5.17 FROM DREWS CREEK SLOUGH, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year and shall be further limited to a diversion of not to exceed 9.65 cfs.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:



This certificate describes that portion of the water right confirmed by Certificate 65633, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered NOV 30 2017, approving Transfer Application T-12278.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
