CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

R. S. DIXON, of Fort Klamath, State of Oregon, has a right to the use of the waters of Sun Creek, tributary of Wood River, for the purpose of Irrigation of 403.6 acres, domestic and stock use.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Klamath County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 12, at Page 269. The date of priority is 1895.

The amount of water to which this right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1/50th of one cubic foot per second per acre irrigated prior to July 20th and 1/80th of one cubic foot per second per acre irrigated thereafter, and shall not exceed 5 acre feet per acre during irrigation season from April 1st to October 1st of each year.

A description of the lands irrigated under such right, and to which the water is appurtenant, is as follows:



This certificate describes that portion of the water right confirmed by Certificate 10902, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered AUG 04 2017, approving Transfer Application T-12400.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

And said right shall be subject to all other conditions and limitations contained in said Decree. The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
