 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LYDA AND ANDERSON MEE
 APPLGATE, OR

confirms the right to use the waters of O'BRIEN and STURGIS FORKS of CARBERRY FORK of APPLGATE RIVER, a tributary of APPLGATE RIVER for DOMESTIC, STOCK, SUPPLEMENTAL IRRIGATION of 43.46 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 16, at Page 523. The date of priority is 1857 for 0.12 CUBIC FOOT PER SECOND (CFS) and 1906 for 0.29 CFS; that the amount of water to which this right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.41 CFS.

The points of diversion are located as follows:

(Note: To the extent of 3.86 acres in SWNE, 5.6 acres in SENE, 3 acres in NWSE, and 2 acres in SWSE, said Sec. 7, the foregoing right is supplemental to the vested right allowed claimants to the use of water from Thompson Creek which is set out in the Rogue River Decree on Page 34, Column 1, under Proof 1020.

It is also supplemental to the vested right allowed claimants to the use of water from Darniel Gulch which is set out in the Rogue River Decree on Page 34, Column 2, under Proof 1026.


The supplemental right allowed herein is limited to use on the land to which it is appurtenant in an amount not exceeding 0.0094 cubic foot per second of water for each acre irrigated during the irrigation season, and the quantity used from all sources shall not exceed 0.02 cubic foot per second of water for each acre irrigated during the irrigation season, except for the 5 acres in the SWSE, said Sec. 7, under the above-stated vested right from Darniel Creek which will be limited to a total diversion from all sources not to exceed 0.026 cubic foot per second for each acre irrigated during the irrigation season)

This certificate describes that portion of the water right confirmed by Certificate 32990, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered SEP 21 2017, approving Transfer Application T-12477.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
