CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO LEO H. ALBERTSON 92022 DOG LAKE LANE LAKEVIEW, OR 97630

confirms the right to use the waters of an UNNAMED DRAINAGEWAY, a tributary of GOOSE LAKE, for the purpose of PRIMARY IRRIGATION OF 6 ACRES AND SUPPLEMENTAL IRRIGATION OF 13.9 ACRES.

This right was perfected under Permit S-45806. The date of priority is JANUARY 19, 1981. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.50 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. THE RIGHT ALLOWED HEREIN SHALL BE LIMITED TO ANY DEFICIENCY IN THE AVAILABLE SUPPLY OF ANY PRIOR RIGHT EXISTING FOR THE SAME LAND AND SHALL NOT EXCEED THE LIMITATION ALLOWED HEREIN. THIS RIGHT IS SUBJECT TO THE TERMS AND CONDITIONS OF A STIPULATION WITH LAKEVIEW WATER USERS, INC. DATED MARCH 2, 1981, RECORDED AT VOLUME 6, PAGE 884, MISCELLANEOUS RECORDS OF THE WATER RESOURCES DIRECTOR.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
