CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STATE OF OREGON  
WATER RESOURCES DEPARTMENT

confirms the right to use the waters of the UMPQUA RIVER, tributary to the PACIFIC OCEAN, for instream use for conservation, maintenance and enhancement of aquatic and fish life, wildlife, fish and wildlife habitat and other ecological values.

This right was perfected under Permit S-24008. The date of priority is DECEMBER 21, 1955, plus one minute. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.10 CFS, or its equivalent in case of rotation, measured at the point of diversion, from March 1 through October 31.

The description of the stream reach in which flows are to be maintained is as follows:

From the authorized point of diversion under Certificate 91450 located at approximately River Mile 103:

Twp	Rng	Mer	Sec	Q-Q	DLC	Measured Distances
25 S	6 W	WM	30	SW SW	38	305 FEET SOUTH AND 1560 FEET EAST FROM THE NW CORNER OF DLC 38

To the head of tide at approximately River Mile 27.2.

Water rights upstream of the original point of diversion shall not be subject to regulation for flows in excess of the quantities to which this instream water right is entitled at the original point of diversion.

Within the specified stream reach, the amount of water to which this right is entitled shall not exceed the quantity of water legally available at the original point of diversion.

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

NOTICE TO ACTIVE DUTY SERVICEMEMBERS: Active duty servicemembers have a right to stay these proceedings under the federal Servicemembers Civil Relief Act. The instream right established by this transfer shall replace a portion of instream water rights established pursuant to ORS 537.341 or 537.346 and shall be in addition to instream water rights established pursuant to ORS 537.348 or 537.470 unless otherwise specified by a subsequent order establishing a new instream water right.

The right is subject to all other terms and conditions of Certificate 91450, and any related decree.

This certificate is issued to confirm an ALLOCATION OF CONSERVED WATER approved by an order of the Water Resources Director recorded in Special Order Volume 105, Page \_\_\_\_\_, approving Conserved Water Application CW-96. This Certificate, together with Certificate 93293 and the conserved water under CW-96, supersedes Certificate 91450, State Record of Water Right Certificates.
