## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of JIMMY CREEK, tributary of ILLINOIS RIVER for IRRIGATION OF 6.6 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Josephine County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 13, at Page 70. The date of priority is 1888. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed one cubic foot per second for each 50 acres of land irrigated during the irrigation season of April 1 to November 1 of each year, or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Prior to diverting water, the water user shall install an approved fish screen at the new point of diversion and shall provide to the OWRD a written statement from Oregon Department of Fish and Wildlife (ODFW) that the installed screen meets the state's criteria, or that ODFW has determined a screen is not necessary.

The water user shall operate and maintain the fish screen at the new point of diversion consistent with ODFW's operational and maintenance standards. If ODFW determines the screen is not functioning properly, and is unsuccessful in working with the water user to meet ODFW standards, ODFW may request that OWRD regulate the use of water until OWRD receives notification from ODFW that the fish screen is functioning properly.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.

This certificate is issued to confirm an HISTORIC ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director entered APR 0.5 2018 approving Transfer
by an order of the Water Resources Director enteredAPR <b>0 5</b> 2018, approving Transfer
Application T-12495, and together with Certificate 93298, supersedes Certificate 13893, State Record of
Water Right Certificates.
