 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

KATHLEEN WANDA
 1450 ROUNDS AVE
 GRANTS PASS OR 97527

confirms the right to use the waters of the A SPRING and LEFT FORK TALLOWBOX CREEK, tributary to TALLOWBOX CREEK for DOMESTIC USE FOR ONE FAMILY and SUPPLEMENTAL IRRIGATION of 2.4 ACRES.

This right was perfected under Permit S-38327. The date of priority is JUNE 26, 1973. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.035 CUBIC FEET PER SECOND (CFS), BEING 0.005 CFS FOR DOMESTIC FROM SPRING AND 0.03 CFS FOR SUPPLEMENTAL IRRIGATION FROM LEFT FORK TALLOWBOX CREEK, or its equivalent in case of rotation, measured at the points of diversion from the source.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to describe the right modified by provisions of an order of the Water Resources Director entered Sept. 28th, 2017, and recorded at Special Order Volume 105, Page 915, approving a partial diminution of the right evidenced by Certificate 55449, State Record of Water Right Certificates. This certificate supersedes Certificate 55449.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
