confirms the right to the use of water perfected under the terms of Permit S-20629. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point(s) of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: LITTLE HERMAN CREEK, A TRIBUTARY OF HERMAN CREEK

PURPOSE OR USE: OPERATION OF SALMON HATCHERY

MAXIMUM RATE: 9.5 CUBIC FEET PER SECOND (CFS), FURTHER LIMITED TO 9.5 CFS FROM LITTLE HERMAN CREEK, 3.4 CFS FROM MIDDLE SPRING, AND 4.4 CFS FROM EAST SPRING, TOTAL NOT TO EXCEED 9.5 CFS

DATE OF PRIORITY: AUGUST 9, 1951

The points of diversion are located as follows:

A description of the place of use is as follows:

The quantity of water diverted at the new points of diversion, together with that diverted at the original point of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion described as follows:

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The Director may require the water user to install a totalizing flow meter or other suitable measuring devices at each point of diversion. If the Director notifies the water user to install totalizing flow meters or other measuring devices, the water user shall install such devices specified by the Director within the period allowed in the notice. Once installed, the water user shall maintain the meters or measuring devices in good working order and shall allow the watermaster access to the meters or measuring devices.

The water user shall maintain the existing headgate(s) and shall make such improvements as may be required by the Department.


Within one year after receiving written notification from the Oregon Department of Fish and Wildlife (ODFW) that a fish screening and/or by-pass device is required, the water user shall install a screening and/or by-pass device, as appropriate, at the each new point of diversion. The fish screening and/or by-pass device must meet ODFW's design and construction standards. Prior to installation, the water user shall obtain written approval from ODFW that the required screening and/or by-pass device meets ODFW's criteria. Once installed the water user shall maintain and operate the fish screening and/or by-pass device as appropriate, at the point of diversion consistent with ODFW's operational and maintenance standards.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described, and is subject to all other conditions and limitations contained in Certificate 24625 and any related decree.

This certificate is issued to confirm TWO ADDITIONAL POINTS OF DIVERSION approved by an order of the Water Resources Director entered OCTOBER 28, 2016, at Special Order Volume 103, Page 287, approving Transfer Application 11249, and together with Certificate XXXXX (cf-24625 for 0.5 CFS under T-11108), supersedes Certificate 24625, State record of Water Right Certificates.
