## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STEVEN A. NYSETH & LORRIE A. NYSETH 39296 HWY 228 SWEET HOME OR 97386

confirms the right to use the waters of the CALAPOOIA RIVER, tributary to the WILLAMETTE RIVER, for PRIMARY IRRIGATION OF 82.0 ACRES and SUPPLEMENTAL IRRIGATION of 10.0 ACRES.

This right was perfected under Permit S-43836. The date of priority is DECEMBER 1, 1978. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.15 CUBIC FEET PER SECOND (CFS), BEING 1.02 CFS FOR PRIMARY IRRIGATION AND 0.13 CFS FOR SUPPLEMENTAL IRRIGATION, or its equivalent in case of rotation, measured at the points of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acrefeet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
