## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BROOKSIDE, INC 1767 12TH ST HOOD RIVER, OR 97031

confirms the right to use the waters of WATER BEARING GRAVEL STRATA, a tributary of INDIAN CREEK for SUPPLEMENTAL IRRIGATION of 9.85 ACRES.

This right was perfected under Permit S-4700. The date of priority is JUNE 19, 1920. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.128 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use herein described and is subject to all other conditions and limitations contained in said permit.

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
