confirms the right to the use of waters of DESCHUTES RIVER, A TRIBUTARY OF THE COLUMBIA RIVER for IRRIGATION OF 520.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Deschutes County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 12, at Page 282 and in Volume 16, at Pages 1 and 390.

PURPOSE OR USE: IRRIGATION OF 520.0 ACRES

North Unit Irrigation District (NUID) shall maintain and operate the existing measurement device at the NUID Canal diversion point on the Deschutes River and shall make such improvements as may be required by the Department.

The water user shall allow the Watermaster access to the meters or measuring devices. Where a meter is located within a private structure, the Watermaster shall be granted access upon reasonable notice.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

The use of water under this right was perfected under CW-81. For purposes of future transfers, it is not the intention to permanently layer this water right with any other right existing for the same lands. Therefore, this water right is not subject to the layered right restrictions contained in ORS 540.510(1), provided the holder of this right remains the applicant of record identified in Special Order Volume 95, Page 520.

This certificate is issued to confirm an ALLOCATION OF CONSERVED WATER approved by an order of the Water Resources Director entered APRIL 10, 2015 and recorded in Special Order Volume 95, Page 520 approving Conserved Water Application CW-81.
