CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WILLOW CREEK for IRRIGATION of 43.7 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Deschutes County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 9, at Page 362. The date of priority is 1892.

The amount of water to which this right is entitled is limited to an amount actually used beneficially for said purposes, and shall not exceed 2.0 acre-feet per acre, measured at the point of diversion from the stream, which may be diverted at a rate not to exceed 1/60<sup>th</sup> of one cubic foot per second per acre during the irrigation season from April 1 to November 1.

The point of diversion is located as follows:

The Director may require the water user to install a totalizing flow meter or other suitable measuring device at the point of diversion. If the Director notifies the water user to install a totalizing flow meter or other measuring device, the water user shall install such device specified by the Director within the period allowed in the notice. Once installed, the water user shall maintain the meter or measuring device in good working order and shall allow the Watermaster access to the meter or measuring device.


The right to use water for the above purpose is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificate 13645 and any related decree.

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered August 27, 2012, at Special Order Volume 88, Page 438, approving Transfer Application T-11428, and together with Certificate 87744, supercedes Certificate 13645, State record of Water Right Certificates.
