CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

FARMERS IRRIGATION DISTRICT
1985 COUNTRY CLUB ROAD
HOOD RIVER, OREGON 97031

confirms the right to use the waters of HOOD RIVER, tributary to COLUMBIA RIVER for SPRAY WATER on Orchards from approximately February 15th through approximately November 15th of each year on 1359.15 acres.

This right was perfected under Permit S-39822.

The date of priority is DECEMBER 5, 1974.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.0 Cubic Feet per Second (CFS), or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located:

2250 FEET NORTH and 470 FEET EAST from the SW CORNER, SECTION 31, being within the NW $\frac{1}{4}$ SW $\frac{1}{4}$ of SECTION 31, TOWNSHIP 2 NORTH, RANGE 10 EAST, W.M.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484 and ORS 536.075. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 183.484, ORS 536.075 and OAR 137-004-0080, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.
