## STATE OF OREGON COUNTY OF WALLOWA CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

S.W. MILES EVANS, OR 97857

confirms the right to use the waters of the LOSTINE RIVER (aka SOUTH FORK WALLOWA RIVER), a tributary to the WALLOWA RIVER for IRRIGATION of 243.9 ACRES, DOMESTIC AND LIVESTOCK and SUPPLEMENTAL IRRIGATION OF 653.5 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 5 at Pages 184-185. The dates of priority are 1882 for Tract 1; 1889 for Tract 2; and 1896 for Tracts 3 and 4.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.5 acre-feet per acre during any period of 30 days prior to July 31 of each year, and thereafter not to exceed 1.0 acre-foot per acre during the entire remainder of the irrigation season.
