CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WOODY AND MEGAN WOLFE

confirms the right to use the waters of the LOSTINE RIVER (aka SOUTH FORK WALLOWA RIVER), a tributary to the WALLOWA RIVER for IRRIGATION of 307.0 ACRES, DOMESTIC AND LIVESTOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 5 at Pages 184-185. The dates of priority are 1882 for 297.1 Acres (Tract 1) and 1896 for 9.9 Acres (Tract 3).

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 7.65 CUBIC FEET PER SECOND (cfs), being 7.41 cfs under 1882 priority and 0.24 cfs under 1896 priority, or its equivalent in case of rotation. The amount of water to which this right is entitled is further limited to an annual volume of 1228.0 ACRE FEET (AF), being 1188.4 AF under 1882 priority and 39.6 AF under 1896 priority, and shall not exceed 1.0 acre-foot per acre during any period of 30 days prior to July 31 of each year, and thereafter not to exceed 1.0 acre-foot per acre during the entire remainder of the irrigation season.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
