CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

C J. ALLEN WALLOWA, OR 97885

confirms the right to use the waters of EAST FORK OF BEAR CREEK (Tract 1), SPRING AND SPRING BRANCHES (Tract 2), SPRING BRANCH (Tract 3), AND LOSTINE RIVER (aka So. Fork of Wallowa River) (Tract 4), tributaries of the WALLOWA RIVER, for IRRIGATION OF 590.1 ACRES, SUPPLEMENTAL IRRIGATION OF 119.0 ACRES, DOMESTIC, AND STOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 5, at Pages 143-144. The dates of priority are:

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.5 acre-feet per acre during any period of 30 days prior to July 31 of each year, and thereafter not to exceed 1.0 acre-foot per acre during the entire remainder of the irrigation season.
