CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WOLFE HEREFORD RANCH, WTK, INC. ATTN: STEPHEN WOLFE 81544 HWY 82 WALLOWA, OR 97885

confirms the right to use the waters of the LOSTINE RIVER (aka SOUTH FORK WALLOWA RIVER), a tributary to the WALLOWA RIVER for IRRIGATION of 26.2 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 5 at Page 182. The date of priority is 1881.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.64 CUBIC FOOT PER SECOND, or its equivalent in case of rotation. The amount of water to which this right is entitled is further limited to an annual volume of 104.8 ACRE FEET, and shall not exceed 1.0 acrefoot per acre during any period of 30 days prior to July 31 of each year, and thereafter not to exceed 1.0 acrefoot per acre during the entire remainder of the irrigation season, if available at the point of diversions, or its equivalent in case of rotation, measured at the points of diversion from the source.

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

Water shall be acquired from the same surface water source as the original point of diversion.

This Certificate, together with Certificate 93532 and a portion of Certificate 93535, supersedes Certificate 91011.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
