CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO VERNON H. VANDYKE RT 1 BOX 87 GASTON, OR 97119

confirms the right to use the waters of a RESERVOIR constructed under Permit R-5267, a tributary of the TUALATIN RIVER for irrigation of 8.7 ACRES, and supplemental irrigation of 69.2 ACRES.

This right was perfected under Permit S-33290. The dates of priority are JULY 11, 1967 for 25.0 ACRE-FEET, and JULY 26, 1968 for 1.0 ACRE-FOOT. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 26.0 ACRE-FEET, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
