confirms the right to use the waters of CANYON ONE AND THAYER DRAIN, tributaries to SNAKE RIVER for PRIMARY IRRIGATION OF 245.7 ACRES AND SUPPLEMENTAL IRRIGATION OF 26.6 ACRES.

This right was perfected under Permit S-47760. The date of priority is FEBRUARY 16, 1982. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 6.81 CUBIC FEET PER SECOND (CFS), BEING 5.28 CFS FROM CANYON ONE AND 1.53 CFS FROM THAYER DRAIN.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

Pursuant to ORS 183.484, ORS 536.075 and OAR 137-004-0080, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.
