 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RAYMOND & LORETTA KASER  
 828 SUN VALLEY AVENUE  
 SILVERTON, OR 97381

confirms the right to use the waters of BUTTE CREEK, a tributary of the PUDDING RIVER for IRRIGATION of 19.8 ACRES.

This right was perfected under Permit S-21641. The date of priority is JULY 25, 1952. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.03 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

6 S	1 E	WM	15	SW NW	39	50 FEET NORTH AND 240 FEET EAST FROM THE WEST ¼ CORNER OF SECTION 15

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of 0.0015 of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 0.75 acre-foot (AF) per acre for each acre irrigated during the irrigation season of each year and an annual volume limitation of 14.85 AF. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:



This certificate describes the water right under Certificate 26123, State Record of Water Right Certificates, reduced in rate by the provisions of an order of the Water Resources Director entered March 3, 2018, approving Allocation of Conserved Water Application CW-100, and together with Certificate 93675 and the conserved water under CW-100 supersedes Certificate 26123.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
