CERTIFICATE OF WATER RIGHT

confirms the right to the use of water perfected under the terms of Permit S-17066. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point(s) of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: OLD MINING TUNNEL AND MARTIN RESERVOIR CONSTRUCTED UNDER PERMIT R-846, A TRIBUTARY OF GRIFFIN CREEK WATERSHED

PURPOSE OR USE: SUPPLEMENTAL IRRIGATION AND AGRICULTURE USE ON 8.0 ACRES, INCLUDING BUT NOT LIMITED TO SUPPLEMENTAL IRRIGATION AND AGRICULTURE USE, DUST AND FROST CONTROL, AND FIRE SUPPRESSION

MAXIMUM RATE: 0.10 CUBIC FOOT PER SECOND

PERIOD OF USE: APRIL 2 TO OCTOBER 31

DATE OF PRIORITY: JUNE 24, 1946

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, irrigated from direct flow and shall be further limited to a diversion of not to exceed 4.5 acre feet per acre for each acre irrigated during the irrigation season from April 2 to October 31, of each year from direct flow and storage from reservoir constructed under Permit R-846, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Measurement, recording and reporting conditions:

- A. The water user shall maintain the totalizing flow meter or other suitable measuring device as approved by the Director in good working order at each point of diversion (new and existing).
- B. The water user shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

The quantity of water diverted at the new point of diversion shall not exceed the quantity of water lawfully available at the original point of diversion described as follows:

The Oregon Department of Fish and Wildlife (ODFW) may require the water user to install an approved fish screen at the new point of diversion within one year after receiving written notification that a fish screen is required. Once installed the water user shall maintain and operate the fish screen at the new point of diversion according to ODFW's operational and maintenance standards. If ODFW determines the screen is not functioning properly, and is unsuccessful in working with the water user to meet ODFW standards, ODFW may request that OWRD regulate the use of water until OWRD receives notification from ODFW that the fish screen is functioning properly.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

This certificate is issued to confirm changes in POINT OF DIVERSION and CHARACTER OF USE approved by an order of the Water Resources Director entered APRIL 20, 2015, at Special Order Volume 95, Page 917, approving Transfer Application 11881, supersedes Certificate 15239, State record of Water Right Certificates.
