This right was perfected under Permit E-176 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon and duly confirmed by order of the STATE WATER BOARD of Oregon, and made and entered of record in the Record of Proceedings of said Board, at Salem, in Volume 1 at page 284. The date of priority is OCTOBER 7, 1912.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.148 CUBIC FOOT PER SECOND, (if available at the original point of diversion) or its equivalent in case of rotation, measured at the point of diversion.
