confirms the right to use the waters of the WILLIAMSON RIVER, a tributary of UPPER KLAMATH LAKE for IRRIGATING 59.7 ACRES.

This right was perfected under Permit S-23654. The date of priority is JUNE 30, 1955. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.49 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
