- B. The water user shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice

The quantity of water diverted at the new point of diversion, together with that diverted at the original points of diversion, shall not exceed the quantity of water lawfully available at the original points of diversion described as follows:

This certificate is issued to confirm changes in POINT OF DIVERSION, PLACE OF USE, AND CHARACTER OF USE approved by an order of the Water Resources Director entered MAY 28, 2014, at Special Order Volume 92, Page 643, approving Transfer Application 11481, and together with Certificate 89312, supersedes Certificate 45430, State record of Water Right Certificates.
