confirms the right to use the waters of LETITIA CREEK, TRIBUTARY OF SOUTH MYRTLE CREEK, for IRRIGATION of 23.2 ACRES.

This right was perfected under Permit S-9729. The date of priority is JULY 3, 1930. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.29 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre, or its equivalent in case of rotation.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The water user shall maintain a headgate, an in-line flow, weir, or other suitable device for measuring and recording the quantity of water diverted.

Water shall be acquired from the same surface water source as the original point of diversion.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
